## Hardware Components



The top view of the TQ6602 Wireless Access Point is illustrated in Figure 1.

The Console Serial port is for manufacturing purposes only.

## **Ethernet LAN Port**

The wireless access point has one Ethernet LAN port on the rear panel, with these operational properties:

- 10Mbps (IEEE 802.3), 100Mbps (IEEE 802.3u), 1000Mbps (IEEE 802.3ab), 2.5Gbps, and 5Gbps (IEEE 802.3bz)
- □ Flow control (IEEE 802.3x)
- □ VLAN tagging (IEEE 802.1Q)
- □ Auto-Negotiation for speed and duplex mode
- □ Auto-MDI/MDIX at 10/100Mbps

The port has the following functions:

- You use it to connect the wireless access point to a device on your wired network, such as Ethernet switch or router. The port makes it possible for wireless clients of the wireless network to gain access to the wired network.
- □ The Ethernet LAN port can also be used to provide the electrical power to the device. The wireless access point is a PoE powered device, meaning it can be powered by a PoE power source on the port. A PoE power source can be a PoE router or switch. such as the x320-10GH Switch from Allied Telesis. Electrical power is transmitted to the wireless access point by the power source over the same network cable that carries the network traffic.
- Power Over<br/>EthernetYou can power the wireless access point as a PoE+ Class 4 device on the<br/>LAN port. Powering the device with PoE requires connecting the LAN port<br/>to a PoE source device.

You can also power the device with an external AC/DC adapter, such as the PWRADP-01 (DA-48Z12) Power Adapter. Refer to "How to Power the Wireless Access Point" on page 28.

- **Connector Type** The LAN port has an eight-pin RJ45 connector. The port uses four pins in the connector at 10/100 Mbps and all eight pins at higher speeds. Refer to the tables in "Port Pinouts" on page 72 for the pin assignments.
  - **Speed** The LAN port can operate at 10/100Mbps/1/2.5/5Gbps. The speed is set automatically with Auto-Negotiation. You cannot disable Auto-Negotiation on the port.

#### Note

You should connect the LAN port to a network device that also supports Auto-Negotiation. The LAN port operates at 10Mbps if it is connected to a network device does not support Auto-Negotiation. This may result in reduced network performance.

**Duplex Mode** The LAN port can operate in either half- or full-duplex mode at 10/100Mbps, and full-duplex mode at higher speeds. The port is IEEE 802.3u-compliant and uses Auto-Negotiation to set the duplex mode. You cannot disable Auto-Negotiation on the port.

#### Note

You should connect the LAN port to a network device that also supports Auto-Negotiation for duplex mode. If connected to a network device that does not support Auto-Negotiation, it operates at half-duplex mode. This will result in a duplex mode mismatch if the network device is operating at full duplex. This may result in reduced network performance.

### Automatic MDIX Detection

The LAN port is IEEE 802.3ab compliant. It features automatic MDIX detection when operating at 10/100Mbps. (Automatic MDIX detection does not apply to higher speeds.) This feature automatically configures the port to MDI or MDIX depending on the wiring configuration of the port on the network device where it is connected.

You cannot disable automatic MDIX detection. For automatic MDIX detection to work properly, this feature must also be present on the network device. The LAN port defaults to MDIX if it is connected to a network device that does not support automatic MDIX detection.

## How to Power the Wireless Access Point

There are three ways to power the wireless access point:

External AC/DC Power Adapter One way to power the wireless access point is with an external AC/DC power adapter, such as the PWRADP-01 (DA-48Z12) Power Adapter from Allied Telesis. Refer to Figure 4. The power adapter is connected to the DC IN connector on the rear panel of the wireless access point.

PoE+ PowerThe wireless access point is a PoE+ powered device, Class 4. It can be<br/>powered by a PoE power source on its Ethernet LAN port. An example of<br/>a PoE power source is the x320-10GH PoE++ Ethernet Switch from Allied<br/>Telesis. Refer to Figure 5.

Both AC/DC F Power Adapter <sup>a</sup> and PoE Power Source

Finally, the device can be powered by both an external AC/DC power adapter and a PoE+ power source. Refer to Figure 6.



Figure 6. Powering the Access Point with Both an External AC/DC Adapter and a PoE+ Power Source

Here are the operating rules of the wireless access point when connected to both an AC/DC power adapter and a PoE+ power source:

- □ The two power sources are not load sharing. The power adapter is the primary power source and PoE is held in reserve. The LAN port operates as a standard Ethernet LAN port, with PoE blocked.
- If the power adapter stops providing power, the wireless access point automatically changes to PoE on the LAN port as its power source.
- If the power adapter resumes providing power, the wireless access point automatically switches back to the power adapter as its primary power source. PoE on the LAN port is blocked and returned to reserve status.

## DC Connector for an External AC/DC Power Adapter

The DC IN connector is for an external AC/DC power adapter, such as the PWRADP-01 Power Adapter from Allied Telesis, shown in Figure 7.



Figure 7. PWRADP-01 Power Adapter

You can power the wireless access point with either an external power adapter on the DC IN connector or a PoE+ power source on the Ethernet LAN port. You can also power it with both power sources. Refer to "How to Power the Wireless Access Point" on page 28 and "Power Specifications" on page 70.

#### Note

Use only power sources that are UL Listed (QQGQ or EPBU), TUV Licensed, or other Safety Agencies approved, and that are suitable for country of use.

## **POWER On/Off Button**

The POWER On/Off button on the rear panel powers on or off the DC IN connector for an external AC/DC power adapter. Here are the button settings:

- In The DC IN connector is On, allowing power from the AC/DC adapter.
- Out The DC IN connector is Off, blocking power from the AC/DC adapter.

Here are the guidelines:

- If the wireless access point is powered by both an AC/DC power adapter and a PoE power source, turning off the DC IN connector shuts off power from the adapter. The access point automatically switches over to PoE for power.
- □ If the wireless access point is powered only by an AC/DC power adapter, turning off the DC IN connector shuts down the device.

## LEDs

The LEDs on the top panel display status information. They are defined in Table 1.

## **Reset Button**

The wireless access point has a Reset button on the rear panel for returning the parameter settings of the device to their default values. You might reset the access point if you want to discard its current configuration or if you forgot the manager password and so cannot manage the device.

To reset the device, press the button for five seconds and release.

You can enable or disable the reset button with the management software. The default setting for the button is enabled. If the access point is installed in a public area, you probably should disable it to protect the device from being reset by unauthorized individuals.

### **Management Tools**

The wireless access point supports the following management tools.

Web Browser The wireless access point has a web browser management interface for configuring the device from your management workstation. The web browser interface allows you to manage one unit at a time and supports both non-secure HTTP and secure HTTPS management sessions. The default is HTTP. The product has been tested with Microsoft Internet Explorer version 11 or later, Microsoft Edge, and Chrome.

Vista Manager EX and AWC Plug-in The wireless access point supports Vista Manager and the Autonomous Wave Control (AWC) plug-in. Configuring and monitoring large numbers of devices is simplified with AWC because you can add multiple devices to management groups and manage them as one unit. The application can also monitor the operations of the wireless access points and automatically adjust operating properties to optimize the performance of your wireless network.

- Verify that the Ethernet cable is long enough to connect to its destination port.
- If the wireless access point will be powered by an AC/DC adapter, verify that an AC power outlet is within six feet of the planned installation site.
- □ The site should allow for easy access to the Ethernet port on the device, so that you can easily connect and disconnect the cable.
- □ The site should allow for adequate air flow around the unit and through the cooling vents on the bottom panel.
- □ The site should not expose the device to moisture or water.
- □ The site should be a dust-free environment.
- The site should not expose the twisted pair cabling to sources of electrical noise, such as radio transmitters, broadband amplifiers, power lines, electric motors, and fluorescent fixtures.

- □ Wall mounting bracket (provided).
- □ Two screws to attach the wall mounting bracket to the access point (provided).
- □ One Ethernet cable.
- External AC/DC power supply (Optional if using PoE. Required if not using PoE or for redundant power).
- □ Kensington lock (optional).

### Note

Allied Telesis recommends installing the wall mounting bracket on the bottom panel of the wireless access point when installing the device on a table. The bracket will facilitate airflow through the cooling fins under the device.

### Note

Please see "Reviewing Safety Precautions" on page 38 and "Choosing a Site for the Wireless Access Point" on page 41 before installing the product.

Perform the following steps to install the wireless access point on a table:

- 1. Place the wireless access point upside down on a table.

- Wall mounting bracket (provided)
- Four (4) M4, 25.0 mm flat-head wood screws and anchors for fastening the mounting bracket (not provided)
- Phillips head screwdriver (not provided)
- Pencil (not provided)

- External AC/DC power supply (Optional if using PoE. Required if not using PoE or for redundant power.)
- □ Kensington lock (optional and not provided)

### Note

The four Phillips head M4 screws/anchors, the Phillips head screwdriver, pencil, external AC/DC power supply and Kensington lock are not included with the product.

# Installing the Mounting Bracket on a Wall or Ceiling

To install the mounting bracket on a wall of ceiling, perform the following procedure:

- 1. Choose the location and orientation for the access point on the wall or ceiling. Refer to Figure 14 on page 48.
- 2. Position the mounting bracket at the selected location and orientation for the access point. Consider the following guidelines.
  - □ The thumbscrew on the mounting bracket is where the front panel of the access point will be.
  - □ The ports and connectors are on the back panel, away from the thumbscrew.
- 3. With a pencil, mark the wall or ceiling with the two key-hole slots of the bracket. Refer to Figure 17.

- 4. Pre-drill the two marked locations for the keyhole slots on the ceiling or wall.
- 5. Install two M4 screws and anchors (if required). Leave the screws loose enough so that the bracket can slide under the screw heads. Refer to Figure 18 on page 52.

### Note

For a wooden wall or ceiling, use M4, 25.0 mm flat-head wood screws and anchors, if required. The screws and anchors are not provided with the wireless access point.

6. Insert the openings of the bracket key-hole slots under the two screw heads and slide the bracket into the narrow end of the key-hole slot openings. Refer to Figure 19 on page 53.

# **Connecting an Ethernet Cable to the Ethernet LAN Port**

This section contains the procedure for connecting an Ethernet cable to the LAN port. For information on cable specifications, refer to "Cable Requirements" on page 27. Please review the following guidelines before connecting the Ethernet cable:

- If you are installing the wireless access point on a ceiling or wall, you might find it easier to connect the cable before placing the unit on the wall mounting bracket.
- To power the wireless access point with PoE, connect the LAN port to a PoE source device. For power specifications, refer to "PoE+ Power Requirements" on page 70.

To connect the network cable, perform the following procedure:

1. Connect an Ethernet cable into the RJ-45 LAN port. Refer to Figure 23.

#### Note

If the other end of the Ethernet cable is already connected to a PoE source device, the wireless access point begins to power on and initialize its management software.

# **Connecting the AC/DC Power Adapter**

1. If you purchased the PWRADP-01 Power Adapter, connect the AC power cord to the power adapter. Refer to Figure 24.

# Starting the First Management Session Without a DHCP Server

After you install and power on the wireless access point, it queries the subnet on the LAN port for a DHCP server. If a DHCP server responds to its query, the unit uses the IP address the server assigns to it. If there is no DHCP server, the access point uses the default IP address 192.168.1.230.

If your network has a DHCP server, use the IP address the server assigns it to it to start the management session. For directions, refer to "Starting a Management Session" on page 67

If your network does not have a DHCP server, you can start the first management session by establishing a direct connection between your computer and the unit by connecting an Ethernet cable to the Ethernet port on the computer and the LAN1 port on the access point. This procedure requires changing the IP address on your computer to make it a member of the same subnet as the default IP address on the access point.

The first management session can also be performed while the device is connected to your network. However, If your network does not have a DHCP server, you still have to change the IP address of your computer to match the subnet of the default address of the access point. Furthermore, if your network is divided into virtual LANs (VLANs), you have to be sure to connect the access point and your computer to ports on an Ethernet switch that are members of the same VLAN.

### Note

The first management session of the access point has to be conducted through the LAN port because the default setting for the radios is off.

### Starting the First Management Session with a Direct Connection

To start the management session with a direct Ethernet connection between your computer and the LAN port on the access point, perform the following procedure:

### Note

If the access point is powered only with PoE, you cannot perform this procedure because it requires a direct connection between your computer and the LAN port on the access point. Instead, perform "Starting the First Management Session Over a Network" on page 65.

- 1. Connect one end of a network cable to the LAN port on the access point and the other end to the Ethernet network port on your computer.
- 2. Change the IP address on your computer to 192.168.1.*n*, where *n* is a number from 1 to 254, but not 230. Refer to the documentation that accompanies your computer for instructions on how to set the IP address.
- 3. Set the subnet mask on your computer to 255.255.255.0.
- 4. Power on the access point.
- 5. Start the web browser on your computer.
- 6. Enter the IP address 192.168.1.230 in the URL field of the browser and press the Enter key.

You should now see the login window, shown in Figure 32 on page 67.

- 7. Enter "manager" for the user name and "friend" for the password. The user name and password are case-sensitive.
- 8. Click the Login button.

### Starting the First Management Session Over a Network

This procedure explains how to start the first management session on the access point when the LAN port is connected to an Ethernet switch on a network that does not have a DHCP server. To start the management session, perform the following procedure:

 If your network has VLANs, check to be sure that your computer and the access point are connected to ports on the Ethernet switch that are members of the same VLAN. This might require accessing the management software on the switch and listing the VLANs and their port assignments. For example, if the access point is connected to a port that is a member of the Sales VLAN, your computer must be connected to a port that is also a member of that VLAN. If your network is small and does not have VLANs or routers, you can connect your computer to any port on the Ethernet switch.

- 2. Change the IP address on your computer to 192.168.1.*n*, where *n* is a number from 1 to 254, but not 230. Refer to the documentation that accompanies your computer for instructions on how to set the IP address.
- 3. Set the subnet mask on your computer to 255.255.255.0.
- 4. Power on the access point.
- 5. Start the web browser on your computer.
- 6. Enter the IP address 192.168.1.230 in the URL field of the browser and press the Return key.

You should now see the logon window, shown in Figure 32 on page 67.

- 7. Enter "manager" for the user name and "friend" for the password. The user name and password are case-sensitive.
- 8. Click the Login button.

### **Starting a Management Session**
