

Allied Telesis Warranty **APAC**

EFFECTIVE ACROSS APAC EXC. ANZ PRIOR TO JULY 1ST, 2010

One Year Warranty

Allied Telesis International warrants solely to the end user purchaser ("Purchaser") that the Allied Telesis hardware product(s) ("Product") purchased from Allied Telesis or its Authorized Distributors will be free from defects in materials and workmanship for a period of (a) twenty four (24) months for Products designed to operate with a power supply from the date the Purchaser Product Warranty Statement buys such Product and (b) sixty (60) months for Products not requiring a power supply from the date the Purchaser buys such Product.

Five Year Warranty

Allied Telesis, Inc. warrants solely to the end user purchaser ("Purchaser") that the Allied Telesis hardware product(s) ("Product") purchased from Allied Telesis or its authorized distributors will be free from defects in materials and workmanship for a period of sixty (60) months from the date the Purchaser buys such Product.

Lifetime Warranty (24 Months Fan and PSU)

Allied Telesis International warrants solely to the end user purchaser ("Purchaser") that the Allied Telesis hardware product(s) ("Product") purchased from Allied Telesis or its Authorized Distributors will be warranted free from defects in materials and workmanship for the lifetime of the Product. Lifetime of the Product means the longer period of either (a) one (1) year from the date Allied Telesis ceases listing the Product on its then-current price list or (b) five (5) years from the date the Purchaser buys such Product; provided, however, that the fan and power supply components thereof will be warranted only for a period of twenty four (24) months from the date the Purchaser buys such Product.

Lifetime Warranty (Five Years Fan & PSU)

Allied Telesis International warrants solely to the end user purchaser ("Purchaser") that the Allied Telesis hardware product(s) ("Product") purchased from Allied Telesis or its Authorized Distributors will be warranted free from defects in materials and workmanship for the lifetime of the Product. Lifetime of the Product means the longer period of either (a) one (1) year from the date Allied Telesis ceases listing the Product on its then-current price list or (b) five (5) years from the date the Purchaser buys such Product; provided, however, that the fan and power supply components thereof will be warranted only for a period of five (5) years from the date the Purchaser buys such Product.

Lifetime Warranty

Allied Telesis, Inc. warrants solely to the end user purchaser ("Purchaser") that the Allied Telesis hardware product(s) ("Product") purchased from Allied Telesis or its authorized distributors will be warranted free from defects in materials and workmanship for the lifetime of the Product. Lifetime of the Product means the longer period of either (a) one (1) years from the date Allied Telesis ceases listing the Product on its then-current price list or (b) up to a maximum of 10 years from the date of purchase and the Purchaser retains ownership of the Product over that time period.
